BYLAW NO. 2013-01

A BYLAW OF THE TOWN OF SHELLBROOK OF SHELLBROOK, SK TO FIX THE RATES TO BE CHARGED FOR THE USE AND CONSUMPTION OF WATER AND TO FIX THE RATES TO BE CHARGED BY WAY OF RENT OR SERVICE CHARGE FOR THE USE OF SEWER

COUNCIL of the *TOWN* of *SHELLBROOK*, in the Province of Saskatchewan, enacts as follows:

1. The charges to be paid by the water consumer whose water service has been turned on shall be those set out in Schedule "A" attached; provided, however, that the minimum shall be payable in every case whether or not any water is consumed.
2. Persons who own or occupy premises drained or that are by bylaw required to be drained into the sewer shall pay for such services a rental rate or service charge in accordance with Schedule "B" attached.
3. Accounts for water service and/or sewer service shall cover a period of one month, and shall be rendered on or before the tenth day of the following month.
4. In conjunction with the above utility charges, the Town shall also impose an "Infrastructure Renewal Fee" to be levied on all properties within the Town that are served with either municipal water and/or sewer services in accordance with Schedule "C" hereto attached or as amended from time to time.
5. Accounts shall be paid within a period of thirty days from the date on which such accounts are rendered. If an account is not paid within the period of thirty days, the water service may be cut off. Prior to reconnecting a service all arrears must be paid along with the following fees:

Reconnect during business hours:	\$50.00
Reconnect outside of regular business hours:	\$100.00
6. A penalty of two (**2%**) percent per month, will be added to all water and sewer accounts outstanding on the first day of the month preceding the billing.
7. The following rate shall be charged to persons obtaining water from the coin operated fill station:

\$1.00 / 130 gallons
8. Bylaw No. **8-2011** is repealed.

The rates, charges, tolls or rent contained in this bylaw shall come into force and take effect on the day of approval being issued by the Local Government Committee or the 1st day of July 2013, whichever is later.

Water rates to be charged for metered water supplied by the Town of Shellbrook shall be as follows:

MONTHLY WATER SERVICE CHARGES:

1. Monthly Water Rates:

2,500 gallons or less	Minimum \$27.65
Over 2,500 gallons	\$9.50 per 1,000 gallons or part thereof

2014

1. Monthly Water Rates:

2,500 gallons or less	Minimum \$30.40
Over 2,500 gallons	\$10.45 per 1,000 gallons or part thereof

2015

1. Monthly Water Rates:

2,500 gallons or less	Minimum \$33.45
Over 2,500 gallons	\$11.50 per 1,000 gallons or part thereof

**SCHEDULE "B"

MONTHLY SEWER SERVICE CHARGES:

1. Monthly Sewer Rates:

2,500 gallons or less	Minimum \$20.25
Over 2,500 gallons	\$0.06 per 1,000 gallons or part thereof

1. Monthly Sewer Rates:

2,500 gallons or less	Minimum \$22.30
Over 2,500 gallons	\$0.07 per 1,000 gallons or part thereof

2015

1. Monthly Sewer Rates:

2,500 gallons or less	Minimum \$24.55
Over 2,500 gallons	\$0.08 per 1,000 gallons or part thereof

SCHEDULE "C"

A flat rate of \$15.00 per month on each property.

A flat rate of \$18.00 per month on each property

A flat rate of \$21.00 per month on each property
